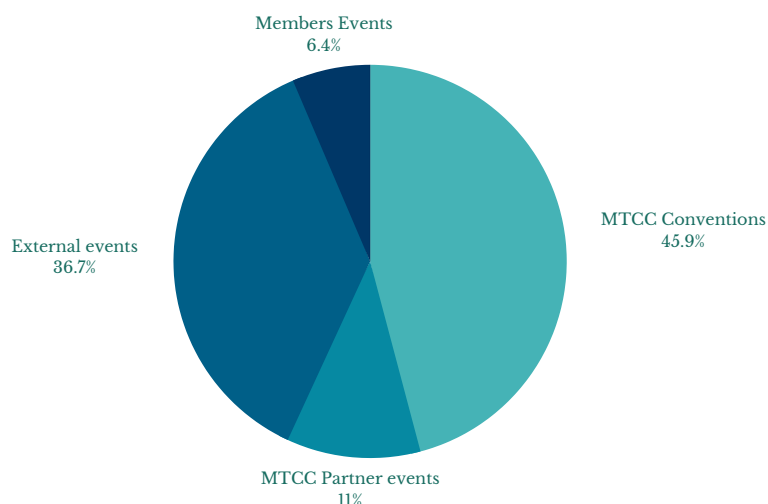

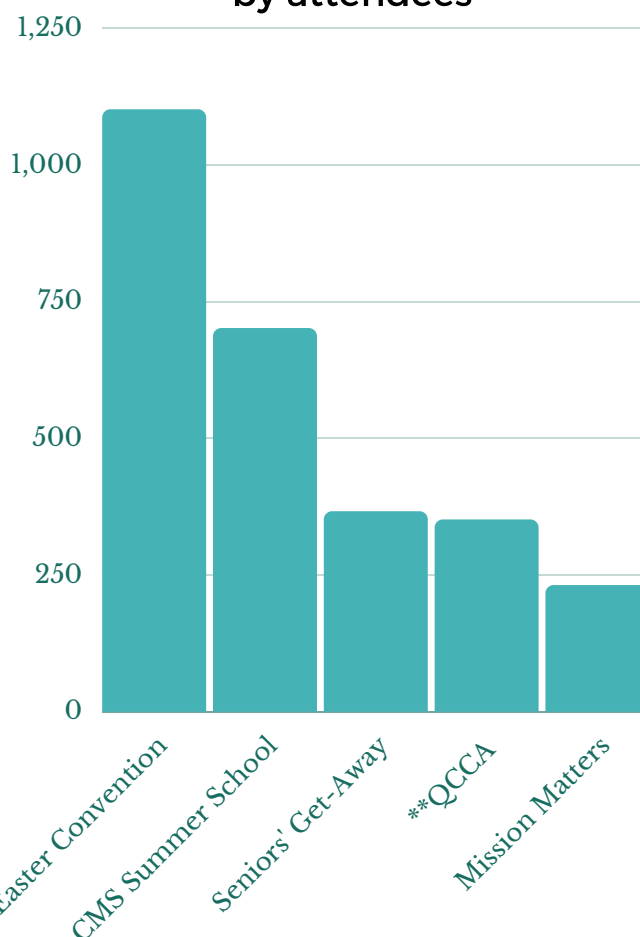




## Top 5 conventions by attendees

2019 began with a change of CEO. After stretching Dave Allan's initial commitment of 1 year out to 5, finishing up as CEO at the end of 2018, John Sheen stepped into the role of Acting CEO from January 1st until Feb 24th when our newly appointed CEO Ross Dinnar began work with us. Thankyou to John for his willingness to step in at this critical time and support the team so skilfully.

Ross' ability to quickly pick up the 'DNA' of MTC has meant that even in his first months, there were critical and wise decisions being taken and the board is grateful that God has brought Ross to us at this time. Ross represents the first opportunity we have had to employ a full time CEO based on site and the benefits have been significant. Not the least of these has been that the MTC Board has been able to focus on its work in the knowledge that the management of MTC is in good hands and being overseen with diligence.

A generous donation from one family was received in January which was put to good use throughout the year. It was such a blessing to have some relief from the financial pressures that usually exist at MTC and we are truly thankful for this and so many other sacrificial gifts that come to MTC.

In March there was a precinct town planning gathering with Town Planner Noel Grummitt. Representatives from all Keswick Rd landowners were present or connected via technology. The purpose was to present a unified approach to Shire Council as they were deciding what kind of zoning we would be given. A satisfactory outcome was achieved and the whole Keswick Road precinct continues to be zoned as a unique area with consistent classification.

March also saw the formalisation of discussions regarding a future apologetics convention. Allan Morgan is heading this up most capably and we now look forward to the SALT Conference launching in 2021.

April brought Easter Convention where we were blessed once again with speakers Richard Gibson and Dave Fowler as well as special elective guest Patricia Weerakoon. The event was fully booked two weeks before commencing - an almighty answer to prayer.

The May AGM ran without a hitch and it was a pleasure to have Peter and Wendy Francis with us for the weekend. It was also a good time of fellowship with people staying for the weekend at Camp Panorama.

June included a small informal presentation expressing appreciation to CMS for 60 years of utilizing the MTCC site for the promotion of cross-cultural Missions.

The annual CMA (Christian Management Advancement) Conference is always a highlight with some 400 Christian not for profit charity representatives gathering for professional development - this time in Melbourne. John Sheen, Ross Dinnar and I attended and we not only enjoyed the conference but used the opportunity to connect with the leaders of other Keswick Rd property owners such as Pioneers, SIM and PCQ, not to mention Reference Council members such as Richard Gibson from Brisbane School of Theology.

Our visit to Melbourne would not have been complete without spending some time at our sister organisation, Belgrave Heights Convention and with their CEO Geoff Gawler.

July brought the opportunity for the MTC Board and Reference Council to meet. A great time of conversation and vision casting was had.

After some negotiation and consideration, August brought the establishment of the MTCC/Vision Christian Media partnership. This has increased our reach into national media as well as giving Vision the scope for increased local influence in SE Queensland. The partnership is proving to be beneficial for both parties. Thank you to Ross, for commencing partnership opportunities with like minded organisations. Thanks too for Ben Farley's enthusiasm to see this partnership happen.

The August Board Retreat weekend went well although I had to leave it up to the team (as I was in hospital at this time). I'm told that John ran the event like clockwork.

In September, MTCC hosted staff from the newly formed Global Trust Partners. They are working closely with CMA and other governance organisations around the world to protect the reputation of Christian organisations against many of the common failures particularly around poor governance and finance. We always benefit from investing time with these great people.

Mission Matters (September) was once again a very successful time of prospective cross-cultural missionaries gathering for challenge, networking and training. The event was overseen by our good friends Tim and Sharon Lithgow from Wycliffe. Mission Matters also had a formal review carried out with the assistance of QTC's Rev Wes Redgen and Brian Allbutt. This review is a valuable resource for planning future events. Thanks to all the Mission Matters team and the review team for the use of their gifts and talents. Special thanks to Allan Morgan who headed up the review process.

October brought the initial planning for the MTCC Global Missions Walk – an onsite cross-cultural missions experience being built into the MTCC property. This work is ongoing but has increased momentum with an expected launch later in 2020.

November Seniors' Get-Away provided an ideal situation to continue the search for some outstanding vacancies on the MTC Board. Both Henk Woning and Lorraine Walker responded to this call and they have both been travelling with us as companions since then.

So once again, a full year with challenges and blessings. It continues to be a privilege to serve in the role of Board Chair and I am very grateful for the support of our membership in so many and varied forms.

Personal Note: "I lift my eyes up to the mountains...."



2019 has been an important year for Mount Tamborine Convention. It is often said that we stand on the shoulders of giants who have gone before us, paving the way forward for a future, and for this we are truly grateful. In saying that, I especially thank Dave Allan for his support during the time of transition from one CEO to another and for John Sheen who stepped into the role till I arrived in February.

A little bit about me. As a proud Queenslander, our family lived on Brisbane's Southside with my formative years at St Bartholomew's Anglican Church at Mt Gravatt. Studying Accountancy took me into a world of transport, logistics, industrial, manufacturing, automotive and finally into Faith based not for profits where I could use my business skills to bring God's light into Ministry objectives. Married to Maree and with two young children, James (12) and Louise (7), my story with MTCC is relatively new.

Coming to attend a Renewal Retreat program in 2016, for the first time ever I turned right into Beacon Road, and it was like a revelation coming to MTC.

Everyone's story and journey is different, and that's what I love about MTC. I love to hear your stories and how you came to MTC, the difference it has brought into your lives.

I feel a real passion for the ministry of MTC and with God's help, will use my time here to shepherd and guide us into the next 60 years.

I am constantly reminded by three main tenets that shape the MTC ministry:

1. Remember the foundations
2. Cultivate the fruit
3. Focus on the future

#### **Remembering the foundations:**

We pay tribute to those who have gone before us who had the foresight to acquire and establish the land and create the vital ministry that developed.

#### **Cultivating the fruit:**

Our high standard of Bible teaching events which feature expository preaching have paved the way for MTC to be known as a place where the Bible is taught with clarity and application.

#### **Focusing on the future:**

This is an area that must now command our attention if we are to build upon 60 years of special events and allow this special place to be relevant into the future.

So how are we doing this? Prayer and supplication has guided our thinking in constructing the new MTC strategic plan. When this document is complete, it will be the beacon to help MTC continue to grow our convention ministry, with events such as the SALT Conference, an apologetics convention that will bring together world class speakers and thought-provoking topics to our site. Our planning includes other conventions, such as 'Men at the Mountain' and other specific events, which will bring together our friends, but also a new audience thirsting for God's Word.

Many changes and improvements are happening across the site. We live with an ageing asset that presents its own challenges and we need to improve it to keep relevancy for the future. I am reminded of that by the many plans that were presented in the past that for some reason or another, did not progress. This does not stop us looking for innovative ways to establish sustainable projects that will continue to develop the usefulness of this site.



2019 brought with it many challenges and opportunities, here is a sample;

- Scenic Rim Council adopted a new Town Plan, which we lobbied hard to preserve the integrity of the precinct. It was a very large piece of work that means the precinct is preserved into the future
- Established Mount Tamborine *Christian Convention* (MTCC) name, the purpose of which is to enable some of our quality Bible teaching events to be held offsite
- Worked through and confirmed MTC's approach to the National Redress Scheme (NRS) which is part of the Royal Commission into Institutional Responses to Child Sexual Abuse
- Created MTCC's own SAFE program for Safe People, Places and Events. This policy goes beyond the previous Childsafe program and encapsulates specially all that MTCC does (details on our website)
- Commenced planning for an Apologetics Convention (now known as the SALT Conference)
- Provided feedback to the Federal Attorney General on the exposure draft of the Religious Discrimination Bill 2019 to protect MTC's interests and further drafts before legislation was enacted.
- Created strategic partnerships with Vision Christian Media and strengthened ties with Belgrave Heights Convention to better plan to share overseas speakers for events
- Refreshed, updated and created operational policies such as
  - Statement of Faith
  - Bushfire Management Plan
  - Sound & noise policy
  - Accommodation policy
- Created registration / reception area in main office and acquired a demountable 12x3m bookshop to operate year round
- Built a registration system to remove the administrative back-of-house burden for events such as Easter Convention and conventions into the future

- Stage upgrade, Chalet refurbishment, kitchen loading ramp at TLC, regular painting and other improvements across the site
- MTCC attended the CMA Conference and Board training events throughout the year
- Refreshed and renewed our marketing material creating a stronger brand to support MTCC's ministry objectives

Finally, it takes a wonderful team to keep the wheels turning at MTCC. A very big thank you to Vivien Barton, Deb Vine, Trish and Phil Montgomery and Lucy Howe for all you do. To our team of regular volunteers, Jim & Grace Vine, Bob Rogers, Peter Witten, Ken Cairns and the many others who come and help – thank you!

To the MTC Board, you are a blessing and enabling support to the role of CEO. Each of you have provided extraordinary welcoming support and guidance which I have benefited from. I'd like to especially thank Bill Vine for always being available to chat, listen to ideas and provide a comforting level of wisdom to each conversation. The best is yet to come!

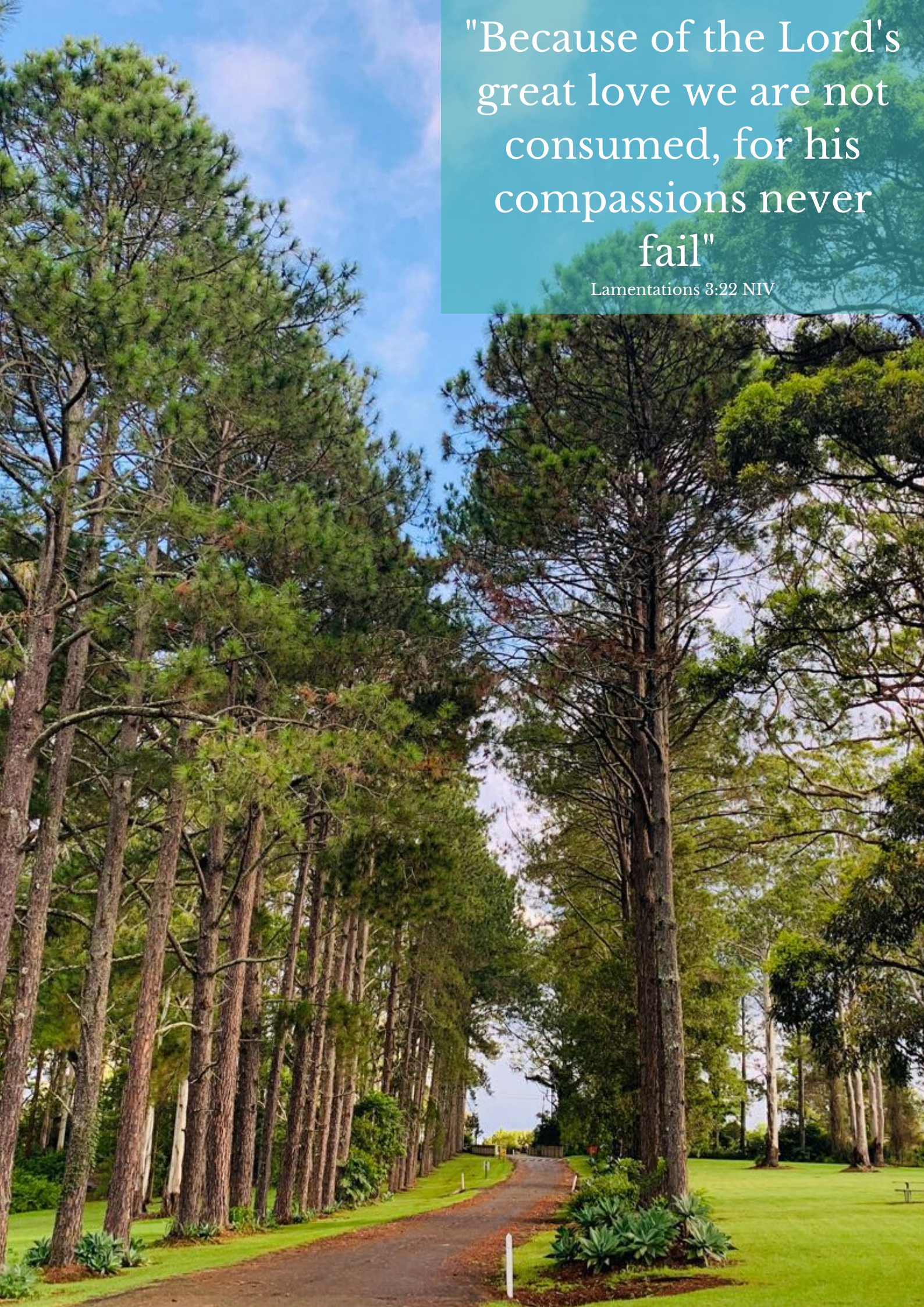

During March 2019, I was appointed by the Board to the office of MTC Board Secretary following the resignation of Anna Roberts due to chronic illness health reasons. This appointment came back to back with my two-months' role as Interim CEO during the CEO selection process. In coming to grips with the constitutional and compliance responsibilities in an exceptionally busy and challenging year, I want to acknowledge the sound foundation established in secretarial areas and records left by Anna Roberts, upon which it has been my sacred privilege to build. I also acknowledge the support and encouragement given to me by all members of the Board including the CEO and Board Companions. Especially I give thanks to God for other members of the Executive Committee, Bill Vine and Rodney Logan and special guidance at times from Duncan Drew.

Almost every day there is something to do to keep up to the normal flow of MTC Board business managing the flow of developing agendas, minutes, Executive Committee meetings, involvement in compliance matters, core documents and the constant upkeep of the records of the Association including membership records. I also acknowledge with thanks, the assistance of the office staff in designated aspects of updating membership records as the need occurs.

MTC Membership stood at 214 at the time of writing this report (10 May 2020).

All compliance records including those specified in the Constitution such as Membership Register, Board Member Records, Board Meeting and Executive Committee Records are continuously maintained up-to-date, as are other compliance records such as the ACNC portal for MTC.

MTC Members will be aware of the great care that the Board has taken for MTC to become a foundation member of Christian Ministry Advancement (CMA) Standards Council and to maintain registration annually through a rigorous process, to date managed and coordinated by Duncan Drew. Contributors to information required for the comprehensive questionnaire are Chair, Treasurer, CEO and Secretary. A comprehensive compliance checklist has been developed for the Board Members to ensure all compliance is met for CMASC and ACNC.

In this report I wish to advise MTC Members more of why the MTC Board advances the Christian interests of the Association by ensuring transparency and high ethical and legal standards through accountability to the principles of CMASC. Christian integrity in ethical, legal, personnel and financial matters undergirds our efforts under God to honour our purposes of providing quality Bible Teaching, support of Missions and Christian Camping.



#### About the Importance of MTC's Accreditation with CMA Standards Council

MTC aspires to be a Christian organisation that can be fully trusted in every aspect of its ministry by the Christian community as well as the rest of Australian society. This means that we need to function well both spiritually and organisationally.



We thank God that there is a Christian organisation “Christian Ministry Advancement Ltd (incorporating Christian Management Australia), a not-for-profit organisation, that can provide other not-for-profit organisations like MTC and churches a distinctively Christian point of accountability through annual accreditation with the CMA Standards Council (CMASC). Compliance is in addition to ACNC and other legal obligations.

In practice, this means that the Christian community can be assured that MTC meets stringent standards and indicates that we are a God centred, prayerful organisation that is governed well, manages finances prudently, is diligent about its legal and civil obligations and treats staff both lovingly and professionally.

Not only does CMASC Accreditation provide assurances of trustworthiness, but opens up a door of opportunity to resources that are available through CMA such as: Governance; Fund-raising; Staff & volunteer management; Financial management; Leadership; Marketplace ministry; Mission and strategy; Legal & compliance; Risk management.

There are two significant aspects to consider:

1. Our Association Members (MTC Members), Board, Staff and Volunteers, Attendees of Conventions and Conferences, may be confident that MTC is an organisation worthy of their TRUST.
2. That donors may confidently entrust their gift to an organisation that has submitted itself to professional external scrutiny as well as normal compliance required by law.

MTC's newly appointed CEO, Ross Dinnar made a very favourable impression on us all, as he and his family experienced their first Easter Convention. We are thankful to our sponsors and ministry partners who provide displays and information to encourage and inspire so many different types of mission and ministry.

We are thankful for those who cook, make coffee, run children's and youth programmes and most importantly pray for this significant ministry. Our mission offering for Australian Indigenous Ministries was \$6748 and we are looking forward to hearing how our brothers and sisters in Elliott have been blessed through Michael and Jorna Jones' ministry to them over the next year.

Below are just a few of the comments we received as feedback:

- I was challenged, inspired and convicted by the excellent preaching. The warmth of the Christian community upheld me and the 700+ voices singing to our great God was beautiful.
- I gained a greater and deeper understanding of the Bible; both my children learnt some memory verses; as a family, we want to read more of the Bible.
- Children's programme is fantastic
- We were greatly challenged by the teaching and encouraged to live a life of holiness in our society which so needs to know God's amazing rescue plan for our lives.
- We are all one in Christ Jesus. Living out the life of Christ is what all Christians need to embrace for a needy changing world that needs the Truth.

As we plan for future Easter Conventions, we continue to be reminded that our God is more Holy than we can imagine, yet gives us the opportunity to walk alongside Him as He guides, protects and uses us to minister to others.

### Seniors' Get-Away

*If you're over 60 and you weren't there – YOU SHOULD HAVE BEEN THERE at the 2019 MTCC Seniors' Get-Away Convention.*

There were some who could not be with us because of the threatening bush-fires, and in spite of the uncertainty we had the largest number of attendees since the Get-Aways began 6 years ago, 350 including day visitors.

Again we had wonderful expository and profoundly relevant Bible teaching from Bishop Rick Lewers, and very appropriate messages on missions from Dr David Price. Both men ministered with a clear evangelical emphasis on the authority of the Scriptures, given in a sensitive, life-application way for seniors to identify with. The hymn singing sessions were greatly appreciated, as were the four electives sessions. However, we must say the very popular Saturday Night Concert was truly a night to remember.

For 2020 we've already booked the Baptist Lodge, the WEC Centre, the Presbyterian Camp Tamborine, and the TLC Centre. Of course, Panorama Homestead and our own Camp Ground – using every available lower bunk in the Keswick Road precinct. The dates for the 2020 Get-Away are November 12 - 15. Registrations open on August 1st, 2020.

From its earliest days, Christian mission has been a core ingredient in the annual Keswick Convention. It began very humbly in 1885 with a prayer meeting, but interest grew and, in 1887, the Convention held its first official missionary meeting at which Hudson Taylor of OMF was the speaker. Over the years, many hundreds of young people have responded on the world mission evenings, indicating their willingness to serve the Lord wherever He called them.

Today emphasis is now no longer exclusively on young people who want to serve in missions, but on believers of all ages and stages of their Christian lives. But our concern is that we should continue to play a significant role in promoting world mission. And our convictions about the uniqueness of Jesus Christ and his exclusive claims remain as strong as ever, as do our convictions about the centrality in mission of the proclamation of the gospel. At Keswick 2019, as God's Word was opened, we saw His heart for a lost and broken world.

2019 was a really good year for Mount Tamborine Convention. We were blessed as we started the year, with a large donation which helped replace the reserve funds from the TLC renovation. MTC held a number of well attended conventions and the usage of our facilities also increased. We continually thank our wonderful members and friends for their donations which are used to improve the site.

The total income for the year was \$531,907 which is well up on last year's total of \$446,603. All the Conventions held at MTC were well attended and brought in income of \$174,237. Our facility hire was \$221,757 which was higher than 2018. The drought conditions had impacted the avocado crop with the yield well down. MTC members and friends were once again generous as \$78,075 was received in donations.

Operating expenses for the year were \$491,328. Employment costs were \$232,249 which includes a full time CEO. Repairs, maintenance and annual compliance costs were slightly higher than last year at \$63,103.

This has resulted in an operating profit of \$40,579 for the year, compared to a profit of \$21,600 for 2018.

MTC has acquired \$45,857 of additional assets, which includes a bookshop, stage renovations, bore pump, mattresses for Camp Panorama and office renovations.

The bank balance as at the end of 2019 was \$56,147 compared to 2018's balance of \$19,690. It was good to increase our cash reserves.

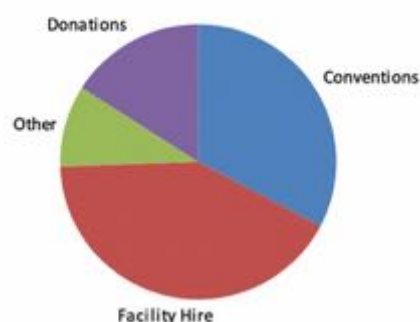

Thank you to Mount Tamborine Convention members for your continued support.

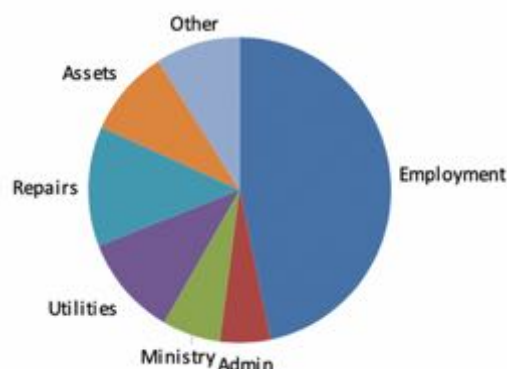

**Note 1: Summary of Significant Accounting Policies**

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the entity's Constitution. The board of management has determined that the entity is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

**a. Income Tax**

This entity is exempt from income tax under the provisions of the *Income Tax Assessment Act*.

**b. Property, Plant and Equipment (PPE)**

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the entity commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either of the unexpired period of the lease or the estimated useful lives of the improvements.

**c. Impairment of Assets**

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

**d. Employee Provisions**

Provision is made for the entity's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

**e. Provisions**

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

**f. Cash on Hand**

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

**g. Accounts Receivable and Other Debtors**

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

**Note 1: Summary of Significant Accounting Policies (cont'd)**

**h. Revenue and Other Income**

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the entity is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

**i. Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

**j. Accounts Payable and Other Payables**

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the entity during the reporting period that remain unpaid. The balance is recognised as a currently liability with the amounts normally paid within 30 days of recognition of the liability.

### INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF MOUNT TAMBORINE CONVENTION

We have audited the financial report of Mount Tamborine Convention, which comprises the assets and liabilities statement as at 31 December 2019, the income and expenditure statement for the year then ended, statement of changes in equity, statement of cash flows, notes comprising a summary of significant accounting policies and other explanatory information, and the certification by members of the committee on the annual statements giving a true and fair view of the financial position and performance of the association.

In our opinion, the accompanying financial report presents fairly, in all material respects, the financial position of the association as at 31 December 2019 and its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements, the requirements of Division 60 of the *Australian Charities and Not-for-profits Commission Act 2012* and the *Australian Charities and Not-for-profits Commission Regulation 2013*.

#### Basis for Opinion

We conducted our audit in accordance with the Australian Auditing Standards.
