## SAFE People, Places & Events – Code of Conduct



## **Code of Conduct**

All paid and unpaid staff, including volunteers, interns or trainees of Mount Tamborine Convention (MTC), Mount Tamborine Conference Centre (MTCC) and Mount Tamborine Christian Convention (MTCC) are responsible for the safety and wellbeing of children and young people who engage with MTCC. All paid and unpaid staff are expected to act in accordance with this Code of Conduct in their physical and online interactions with children and young people under the age of 18 years.

I will:	<ul> <li>Act in accordance with MTC's child safety and wellbeing policies and procedures at all times.</li> </ul>
	<ul> <li>Behave respectfully, courteously and ethically towards children and their families and towards other staff.</li> </ul>
	<ul> <li>Listen and respond to the views and concerns of children, particularly if they communicate (verbally or non-verbally) that they do not feel safe or well.</li> </ul>
	<ul> <li>Promote the human rights, safety and wellbeing of all children in MTCC's Safe People, Places and Events policy.</li> </ul>
	Demonstrate appropriate personal and professional boundaries.
	<ul> <li>Consider and respect the diverse backgrounds and needs of all children.</li> </ul>
	<ul> <li>Create an environment that promotes and enables children's participation and is welcoming, culturally safe and inclusive for all children and their families.</li> </ul>
	<ul> <li>Involve children in making decisions about activities, policies and processes that concern them wherever possible.</li> </ul>
	<ul> <li>Contribute, where appropriate, to MTC's policies, discussions, learning and reviews about child safety and wellbeing.</li> </ul>
	<ul> <li>Identify and mitigate risks to children's safety and wellbeing as required by MTC's risk assessment and management policy or process.</li> </ul>
	<ul> <li>Respond to any concerns or complaints of child harm or abuse promptly and in line with MTC's policy and procedure for receiving and responding to complaints.</li> </ul>
	<ul> <li>Report all suspected or disclosed child harm or abuse as required by the National Principles for Child Safe Organisations and by MTC's policy and procedure on internal and external reporting.</li> </ul>
	Comply with MTC's protocols on communicating with children.
	<ul> <li>Comply with National Principles for Child Safe Organisations and MTC's policies and procedures on record keeping and information sharing.</li> </ul>
I will not:	Engage in any unlawful activity with or in relation to a child.
	<ul> <li>Engage in any activity that is likely to physically, sexually or emotionally harm a child.</li> </ul>

## SAFE People, Places & Events – Code of Conduct



	Unlawfully discriminate against any child or their family members.
	Be alone with a child unnecessarily.
	<ul> <li>Arrange personal contact, including online contact, with children I am looking after at MTC for a purpose unrelated to MTC's activities.</li> </ul>
	<ul> <li>Disclose personal or sensitive information about a child, including images of a child, unless the child and their parent or legal guardian consent or unless I am required to do so by MTC's policy and procedure on reporting.</li> </ul>
	<ul> <li>Use inappropriate language in the presence of children, or show or provide children with access to inappropriate images or material.</li> </ul>
	<ul> <li>Work with children while under the influence of alcohol or prohibited drugs.</li> </ul>
	<ul> <li>Ignore or disregard any suspected or disclosed child harm or abuse.</li> </ul>
